On January 4, 1985, the President's fourth special message for fiscal year 1985 was submitted to the Congress pursuant to the Impoundment Control Act of 1974. The special message proposes two new deferrals totalling \$11,000,000 and five revised deferrals now totaling \$5,405,581,139 for fiscal year 1985. Our report follows:

As reflected in the Office of Management and Budget's cumulative impoundment report dated January 9, 1985, releases of funds in these accounts have been made totalling \$2,161,285,000 for approved programs. Accordingly, the remaining deferral amount for these accounts totals \$2,018,447,508 as opposed to the \$4,179,732,508 reported by the President.

The most recent apportionment schedule dated December 10, 1984 shows that the amount to be deferred in the Army's Wildlife Conservation account is \$810,332, rather than the amount of \$825,000 listed as deferred on a previous apportionment schedule dated August 27, 1984. Consequently, the total amount to be deferred is now \$1,177,059 as opposed to the \$1,191,677 reported by the President, a difference of \$14,618.


