Dear Mr. Chairman:

This fact sheet, prepared in response to the Subcommittee's request, details the nature and volume of mailings by selected religious organizations under special bulk third class nonprofit permits during March and April 1988. The religious organizations, as selected by the Subcommittee, are the ministries of (1) Jerry Falwell, (2) Pat Robertson, (3) Jimmy Swaggart, (4) Oral Roberts, (5) Rex Humbard, (6) Robert Schuller, (7) Peter Popoff, and (8) Billy Graham.

The use of third class rates carries with it the authority for the Postal Service to open and inspect the mail pieces. Thus, for organizations associated with the named individuals and authorized to mail at the special bulk third class nonprofit rate, we asked the 12 post offices listed below to furnish an example of each different piece mailed and a mailing statement for each mailing. Among other things, the statement showed the number of pieces mailed. Some of the individuals were associated with more than one organization. For example, Jerry Falwell is associated with Liberty University, the Moral Majority, the Old Time Gospel Hour, and the Thomas Road Baptist Church.

The above post offices were selected because they were frequently used by the organizations during 1987. At our request the post offices began collecting mailing statements and examples of pieces mailed in early March 1988. With the Subcommittee's concurrence, we instructed them to stop on April 29, 1988. Post offices in Altoona, Baltimore, and Holliston received no mail from the designated organizations during this period.

The examples collected by the post offices and mailed to us included solicitations for contributions; advertisements and subscription renewals; religious merchandise and publications; and notices of events, such as changes in the time of television and radio programs.

As shown in appendixes I through VIII, we judgmentally categorized by type of content the mailings made by each organization. This effort was complicated because some mail pieces included several different items, and some mailings included pieces that were not all identical. For the mailings with nonidentical pieces, the example obtained may not be fully representative of all of the pieces included in the mailing. Also, we received some duplicate copies of mailing statements. We tried to eliminate the duplication, but it is possible that some of the quantities shown are overstated.
