Proposed Deperrals pursuant to Impoundment Control Act of 19747 January 11, 1979

To the President of the Senate and the Speaker of the House of Representatives

On December 7, 1978, we received copies of the President's third special message for fiscal year 1979 that was transmitted to the Congress pursuant to the Impoundment Control Act of 1974.

Office special message proposed 10 new deferrals totalling about \$111 million, and revisions to four previously proposed deferrals as follows.
