# RESOLUTION

Directing certain standing committees to inventory and review existing, pending, and proposed regulations and orders from agencies of the Federal Government, particularly with respect to their effect on jobs and economic growth.

1       *Resolved, That each standing committee designated in section 3 of this resolution shall inventory and review exist-*

1   *ing, pending, and proposed regulations, orders, and other*  
2   *administrative actions or procedures by agencies of the Fed-*  
3   *eral Government within such committee's jurisdiction. In*  
4   *completing such inventory and review, each committee shall*  
5   *consider the matters described in section 2. Each committee*  
6   *shall conduct such hearings and other oversight activities*  
7   *as it deems necessary in support of the inventory and re-*  
8   *view, and shall identify in any report filed pursuant to*  
9   *clause 1(d) of rule XI for the first session of the 112th Con-*  
10   *gress any oversight or legislative activity conducted in sup-*  
11   *port of, or as a result of, such inventory and review.*

12   **SEC. 2. MATTERS FOR CONSIDERATION.**

13       *In completing the review and inventory described in*  
14   *the first section of this resolution, each committee shall*  
15   *identify regulations, executive and agency orders, and other*  
16   *administrative actions or procedures that—*

- 17           *(1) impede private-sector job creation;*
- 18           *(2) discourage innovation and entrepreneurial*  
19           *activity;*
- 20           *(3) hurt economic growth and investment;*
- 21           *(4) harm the Nation's global competitiveness;*
- 22           *(5) limit access to credit and capital;*
- 23           *(6) fail to utilize or apply accurate cost-benefit*  
24           *analyses;*
- 25           *(7) create additional economic uncertainty;*

1                   (8) are promulgated in such a way as to limit  
2                   transparency and the opportunity for public com-  
3                   ment, particularly by affected parties;  
4                   (9) lack specific statutory authorization;  
5                   (10) undermine labor-management relations;  
6                   (11) result in large-scale unfunded mandates on  
7                   employers without due cause;  
8                   (12) impose undue paperwork and cost burdens  
9                   on small businesses; or  
10                  (13) prevent the United States from becoming  
11                  less dependent on foreign energy sources.
