### **CRITICAL REQUIREMENT**

**You MUST email your PAID pay.gov receipt to CAE to be added to a course roster. Payment alone does not register you.**

### **Registration Overview**

- 1 Pay for the course through pay.gov
- 2 Email the paid receipt to CAE
- 3 CAE confirms payment and adds you to the roster
- 4 You receive Zoom Events emails to complete registration

### **Step 1: Submit Payment on pay.gov**

- 1 Go to <https://www.pay.gov> and search for "GAO"
- 2 Select Center for Audit Excellence (CAE)
- 3 Enter Agreement/Bill Number: 900643-25-001 (numbers and dashes only; do not include "CAE")
- 4 Pay via Credit/Debit Card, PayPal, Venmo, or ACH
- 5 Include your organization's payment POC email in the Additional Information field

- 2 Session dates
- 3 Registrant name
- 4 Registrant email
- 5 Purchaser email (if different)
