CHAPTER 1

INTPODUCTION

During the past 30 years, the Federal Government has demonstrated a growing concern over discrimination and its effects. The courts led the way, providing substantive civil rights meaning to the due process and equal protection clauses of the Constitution. The executive branch followed, through a series of Executive orders, directing Federal departments and agencies to prohibit discrimination in their own activities and in the practices of those with whom they deal. The Congress was the last of the three branches to act, but since 1957 it has enacted numerous nondiscrimination and equal opportunity laws. Among these have been such landmark legislation as the Civil Rights Acts of 1957, 1960, 1964, and 1968; the Equal Pay Act of 1963; and the Equal Employment Opportunity Act of 1972. Other nondiscrimination legislation has been enacted as part of new programs, such as revenue sharing, and as amendments to existing program legislation, such as title.IX of the Education Amendments of 1972.

Entities whose activities are subject to the provisions of these laws and orders include Federal contractors and subcontractors; Federal grantees and their subcontractors; other employers, labor organizations, individual citizens, and commercial establishments; and Federal, State, and local governments, both in their roles as employers and as providers of public services, benefits, and facilities.

Recently, the President submitted Reorganization Plan No. . of 1978 to the Congress. The plan, which became effec-'iv. on May 6, 1978, transfers to the Equal Employment Opportunity Commission several nondiscrimination responsibilities currently held by other governmental units. These authoricies, which will be transferred on an incremental basis, include the following:

- --To coordinate, after July 1, 1978, all Federal equal employment programs, an authority currently held by the Equal Employment Opportunity Coordinating Council.
- --To ensure, after January 1, 1979, equal employment opportunity for Federal employees, now held by the U.S. Civil Service Commission.
- --To enforce, after July 1, 1979, the Equal Pay Act and the Age Discrimination in Employment Act, now held by the Department of Labor.

· • • •

The President announced that he will issue an Executive order consolidating responsibility for ensuring nondiscrimination compliance by Federal contractors in the Department of Labor's Office of Federal Contract Compliance Programs. Labor currently shares this authority with 11 other governmental departments and agéncies. This consolidation of contract compliance responsibility will take effect October 1, 1978. The President also said that by the end of 1980 he would review all aspects of equal employment opportunity enforcement to determine whether further changes are desirable.

Virtually every Federal department, agency, or commission has been assigned reponsibility for enforcement of at least one nondiscrimination/equal opportunity program and many agencies have responsibility for several such programs.

We have identified a total of 87 Federal laws and Executive orders which deal with civil rights and nondiscrimination. We have classified these laws into eight categories: employment; public services, benefits and facilities (except housing and education); housing; education; credit; public accommodations; voting and jury service; and criminal and general civil remedy. Appendix I shows (1) the total number of laws and Executive orders included in each category and (2) the number of times each prohibited basis of discrimination is mentioned within each category. Because many of the laws and orders refer to more than one program category, the numbers add up to more than 87.

Total Federal expenditures in this area have increased substantially between fiscal year 1976 and fiscal year 1978. Expenditures have risen from \$375 million to an estimated \$467 million during this period. Appendices II, III, and IV provide additional information concerning Federal expenditures. This information was provided to us by the Office of Management and Budget.

METHODOLOGY

ί.

We undertook this study to identify and compile in a readily usable form pertinent information concerning the major Federal laws and Executive orders for administering nondiscrimination and equal opportunity programs.

In performing the study, we requested Federal departments, agencies, boards, and commissions to provide information concerning programs they administer which implement Federal laws and Executive orders pertaining to nondiscrimination and equal opportunity. Each was asked to identify its implementing regulations and guidelines which describe the

administration and enforcement of their responsibilities, including scope of coverage, type of discrimination prohibited, and method of implementation. Officials of some departments, agencies, boards, and commissions were interviewed to clarify information provided and to obtain additional data. We also obtained information from the JURIS system, a computerized information retrieval system for the United States Code that is maintained by the Department of Justice, and reports and analyses prepared by the Office of Management and Budget, the Congressional Research Service, the U. S. Commission on Civil Rights, and private research organizations.

CHAPTER 2

LAWS AND EXECUTIVE ORDERS FOR

ADMINISTERING NONDISCRIM-

INATION AND EQUAL OPPORTUNITY PROGRAMS

The major laws and Executive orders for administering civil rights and equal opportunity programs are summarized on the following pages. Each appears under one of the following program categories to which it 1s most directly related: (1) employment, (2) public services, benefits, and facilities, (3) housing, (4) education, (5) credit, (6) public accommodations, (7) voting and jury service, and (8) criminal and general civil remedy.

Information is presented for the laws and Executive orders in the format discussed below:

- --Citation: Public Law, Statutes at Large, United States Code, or Federal Register reference(s).
- --Description: Brief explanation of the law, statute, or Executive order.
- .--Bases: The type of discrimination prohibited, such as race, sex, or religion.
- --Impact entities: The persons or organizations which are prohibited from practicing discrimination. These include Federal, State, and local governments; Federal contractors and grantees; private employers; labor organizations; and private citizens.
- --Agency roles: The agencies which enforce the laws or Executive orders are classified by their responsibilities:
 - (1) <u>Supervisory</u>--an agency designated the lead agency or agency with primary policy setting and coordinating responsibilities.
 - (2) <u>Administering</u>--an agency which implements the policy and coordination guidelines of a supervisor agency.
 - (3) Independent--an agency which is responsible for implementation of a law or Executive order. Two or more agencies can each have independent

authority for enforcment sections of the same law or Executive order.

--Regulations: The citation to the primary regulations used by agencies to implement nondiscrimination provisions, laws, or Executive orders.

EMPLOYMENT PROGRAMS

1. Title VII, Civil Rights Act of 1964, as amended

- <u>Citation</u>: P.L. 88-352, July 2, 1964, as amended by P.L. 92-261, Mar. 24, 1972, 42 U.S.C. 2000e-2000e-13, 2000e-15, and 2000e-17 (Supp. II, 1972).
- Description: Prohibits discrimination in classification, selection, hiring, upgrading, benefits, layoffs, or any other condition of employment. The act created and empowered the Equal Employment Opportunity Commission to seek out and eliminate unlawful employment practices in accordance with procedures prescribed in the law.

Bascs: Race, color, religion, sex, national origin.

Impact entities: Private employers with 15 or more employees, State and local governments, labor organizations, employment services, apprenticeship systems.

Agency roles:

Independent: Equal Employment Opportunity Commission. Department of Justice.

Regulations: 29 C.F.R. 1601, et seq.

2. Executive Order 11246, Equal Employment Opportunity -Government Contractors and Subcontractors, as amended

<u>Citation</u>: 30 F.R. 12319, Sept. 24, 1965. 42 U.S.C. 2000e note (1970).

<u>Description</u>: Establishes a program to require Federal contractors and subcontractors to eliminate employment discrimination and take affirmative action to provide equal employment opportunity. The program is divided

into two parts which cover construction and nonconstruction (supply and services) contractors. Certain Federal agencies, referred to as compliance agencies, are responsible for enforcing the order and related guidelines.

Bases: Race, color, religion, national origin, sex.

Impact entities: Federal contractors and their subcontractors.

Agency roles:

Supervisory: Department of Labor.

Independent: Department of Justice.

Administering:

Departments of Commerce. Defense, Energy. Health, Education, and Welfare. Housing and Urban Development. the Interior. Transportation. the Treasury. Environmental Protection Agency. General Services Administration. Small Business Administration.

^{1/}The President's Reorganization Plan No. 1 of 1978, which became effective on May 6, 1978, states that the functions of compliance agencies will be transferred by Executive order to the Department of Labor in October 1978. The President has indicated that by the end of 1980 he will determine whether enforcement of Executive Order 11246, as amended, should be tranferred to the Equal Employment Opportunity Commission.

3. Section 717, Equal Employment Opportunity Act of 1972

<u>Citation</u>: P.L. 92-261, Mar. 24, 1972, 42 U.S.C. 2000e-16 (Supp. II, 1972).

Description: Requires that all personnel actions affecting employees or applicants for employment in the Federal Government be made free of discrimination. Federal departments and agencies are required to develop an affirmative action program for all employees and applicants for employment. The Civil Service Commission is required to make an annual review of these programs.

Bases: Race, color, religion, sex, national origin. Impact entities: Federal departments and agencies.

Agency roles:

4. Executive Order 11478, Equal Employment Opportunity in the Federal Government, as amended

<u>Citation</u>: 33 P.R. 12985, Aug. 8, 1969. 42 U.S.C. 2000e ncte (1970).

- Description: Sets forth U.S. policy of providing equal opportunity in Federal employment, prohibiting discrimination in employment, and promoting equal employment opportunity through affirmative action programs in each Federal department and agency. Federal departments and agencies are required to develop affirmative action programs for all employees and applicants for employment. The Civil Service Commission is required to make an annual review of chese programs.
- 1/The President's Reorganization Plan No. 1 of 1978, which became effective on May 6, 1973, transfers enforcement of this section to the Equal Employment Opportunity Commission. The transfer will take place after January 1979.

Bases: Race, color, religion, sex, national origin. Impact entities: Federal departments and agencies. Agency roles:

<u>Supervisory</u>: Civil Service Commission. <u>1</u>/ <u>Administering</u>: Federal departments and agencies. Regulations: 5 C.F.R. 713.

5. <u>Government Organization and Employees Act of 1966, as</u> <u>amended</u>

<u>Citation:</u> P.L. 89-554, Sept. 6, 1966, 5 U.S.C. 7151, et seq. (1976).

<u>Description</u>: Establishes U.S. policy of insuring equal employment opportunity for Federal employees without discrimination on the bases identified below.

Bases: Race, color, religion, sex, national origin, marital status, physical handicap.

Impact entities: Federal departments and agencies.

Agency roles:

Supervisory: Civil Service Commission.

Administering: Federal departments and agencies.

Regulations: 5 C.F.R. 713.

6. Executive Order 10577, Civil Service Rules, as amended

<u>Citation</u>: 19 F.R. 7521, Nov. 22, 1954 5 U.S.C. 3301 note (1976)

Description: Promulgates Civil Service Commission rules for the Federal competitive service. The order prohibits discrimination against

employees or applicants for employment in the Federal competitive service on the bases identified below.

Bases: Race, political affiliation, religious belief.

Impact entities: Federal departments and agencies.

Agency roles:

Supervisory: Civil Service Commission.

Administering: Federal departments and agencies.

Regulations: 5 C.F.R. 713.

7. Executive Order 11491, Labor-Management Relations in the Federal Service, as amended

<u>Citation</u>: 34 F.R. 17605, Oct. 29, 1969 5 U.S.C. 7201 note (1976).

Description: Sets forth the Government's policy in all dealings with Federal employees and organizations representing such employees. It established the Federal Labor Relations Council which is responsible for overall administration of the order. The order prohibits Federal employee labor organizations from discriminating against an employee with regard to the terms or conditions of membership on the bases set out below.

Bases: Race, color, creed, sex, age, national origin. Impact entities: Federal employee labor organizations.

Agency roles:

<u>Supervisory</u>: Federal Labor Relations Council, Department of Labor.

Administering: All executive agencies, except intelligence agencies, Department of State, U.S. Information Agency, Agency for International Development, and the Tennessee Valley Authority.

<u>Citation</u>: 60 Stat 1030, Aug. 13, 1946. 22 U.S.C.807 (1970).

<u>Description</u>: Prohibits discrimination in the personnel practices of the U.S. Foreign Service on the bases identified below.

Bases: Race, color, cleed, political beliefs, or affiliations.

Impact entities: Federal agencies employing Foreign Service officers.

Agency roles:

Independent: Department of State. U.S. Information Agency.

Regulations: None

9. Executive Order 11636, Employee-Management Relations in the Foreign Service

<u>Citation:</u> 36 F.R. 24901, Dec. 17, 1971. 22 U.S.C. 801 note (Supp. I, 1971).

<u>Description</u>: Sets forth U.S. policy with respect to dealings between foreign affairs agencies and their employees and organizations representing their employees. The order also prohibits such employee organizations from discriminating against an employee with regard to the terms or conditions of membership on the bases identified below.

Bases: Race, color, creed, sex, age, national origin.

Impact entities: Federal agencies employing Foreign Service officers.

Agency roles:

Supervisory: Board of the Foreign Service.

Administering: Department of State. U.S. Information Agency. Agency for International Development.

Regulations: 22 C.F.R. 14, 15, and 16.

10. Equal Pay Act of 1963, as amended

<u>Citation</u>: P.L. 88-38, June 10, 1963, 29 U.S.C 206(d)(1970).

Description: Amended the Fair Labor Standards Act of 1938 (29 U.S.C. 201, et seq.) to prohibit employers from compensating members of one sex at a lower rate than members of the other sex for equal work. \sim

Bases: Sex.

Impact entities: Private employers, State and local governments, labor unions in their capacity as employers.

Agency roles:

Independent: Department of Labor. 1/

Regulations: 29 C.F.R. 800.100, et seq.

11. Section 501, Rehabilitation Act of 1973, as amended

<u>Citation</u>: P.L. 93-112, Sept. 26, 1973, 29 U.S.C. 791 (Supp. IV, 1974).

Description: Established within the Federal Government the Interagency Committee on Handicapped Employeds which, along with the Civil Service Commission, reviews the employment graduates of the Federal Government with the sector to handicapped individuals a state to administrative changes for legislative and administrative changes to foster such e ployment practices. The act requires hed and agencies to develop affirmative action programs for the employment of handicapped individuals. The

1/The President's Reorganization Plan No. 1 of 1978, which became effective May 6, 1978, transfers enforcement of this act to the Equal Employment Opportunity Commission in July 1979. act also requires the Commission to develop policies and procedures which will foster the employment of individuals who have received rehabilitation services under a program for handicapped individuals.

Administering: Federal departments and agencies.

12. Section 503, Rehabilitation Act of 1973, as amended

Citation: P.L. 93-112, Sept. 26, 1973, 29 U.S.C 793 (Supp. IV, 1974).

Description: Requires that any contract in excess of \$2,500 entered into by any Federal department or agency for the procurement of personal property and nonpersonal services (including construction) shall contain a provision requiring that in employing persons to carry out such contract the contractor shall take affirmative action to employ and advance in employment qualified handicapped individuals. This requirement also applies to subcontracts in excess of \$2,500 entered into by such contractors.

Bases: Handicap.

13. Age Discrimination in Employment Act of 1967, as amended

<u>Citation</u>: P.L. 90-202, Dec. 15, 1967, as amended by P.L. 95-256, Apr. 6, 1978, 29 U.S.C. 621-633, 634,

Description: Prohibits employers, employment agencies, and labor organizations from discriminating in employing any individual because of such individual's age. These prohibitions are limited to individuals who are at least 40 years of age but less than 70 years of age.

Bases: Age.

<u>Impact entities</u>: Private employers, State and local governments, labor organizations, employment agencies.

Agency rolas:

Independent: Department of Labor. 1/

Regulations: 29 C.F.R 850, et seq.

1/The President's Reorganization Plan No. 1 of 1978, which became effective May 6, 1978, transfers enforcement of this act to the Equal Employment Opportunity Commission in July 1979. 14. Fair Labor Standards Act Amendments of 1974. as amended

<u>Citation</u>: P.L. 93-259, Apr. 8, 1974, as amended by P.L. 95-256, Apr. 6, 1978, 29 U.S.C. 633(a).

Description: Prohibits age discrimination in Federal Government employment. This prohibition is limited to persons who are at least 40 years of age. The act does not set an upper age limit.

Bases: Age.

Impact entities: Federal departments and agencies.

Agency roles:

Independent: Civil Service Commission. 1/ Library of Congress.

Administering: Federal departments and agencies.

Regulations: 5 C.F.R. 713.501.

15. Executive Order 11141, Equal Employment Opportunity--Age Discrimination

<u>Citation</u>: 29 F.R. 2477, Feb. 12, 1964. 5 U.S.C. 3301 note (1976).

Description: Federal contractors and subcontractors are prohibited from discriminating in the employment of any individual because of age.

Bases: Age.

Impact entities: Federal contractors and subcontractors.

Agency roles:

16. Federal Communications Act, as amended

<u>Citation:</u> 48 Stat. 1084, June 19, 1934. 47 U.S.C. 151, <u>et seq</u>. (1970).

Description: Authorized the establishment of the Federal Communications Commission for the purpose of regulating interstate and foreign commerce in communication by wire and radio. The Commission, because of the national policy against employment discrimination and pursuant to its own independent authority under the act, has adopted rules prohibiting employment discrimination by those entities it regulates.

Bases: Race, color, religion, national origin, sex.

Impact entities: Broadcasters, common carriers, cable television operators, and private employers.

Agency roles:

Independent: Federal Communications Commission.

Regulations: 47 C.F.R 73.125, et seq.

17. Comprehensive Employment and Training Act of 1973, as amended

<u>Citation:</u> P.L. 93-203, Dec. 28, 1973. 29 U.S.C. 848f; 991 (Supp. IV, 1974).

- <u>Description</u>: All grants, contracts or agreements which provide Federal financial assistance under the act must contain a provision prohibiting discrimination against program participants or applicants for participation in such programs on the bases identified below.
- Bases: Race, creed, color, national origin, political affiliation or beliefs, sex.

Impact entities: State and local governments, labor organizations, private grantees.

Agency roles:

<u>Independent</u>: Department of Labor. Department of Justice.

Regulations: 29 C.F.R. 97.331; 98.21.

18. Apprenticeship Amendments of 1973

<u>Citation</u>: 50 Stat. 664, Aug. 16, 1937, as amended by P.L. 93-198, Dec. 24, 1973, 29 U.S.C. 50 (Supp. IV, 1974).

<u>Description</u>: Regulations ptomulgated under the act set forth policies and procedures promoting equality of opportunity in apprenticeship programs registered with the U.S. Department of Labor or with apprenticeship programs registered with recognized State apprenticeship agencies. These regulations prohibit discrimination on the bases identified below.

Bases: Race, color, religion, national origin, sex.

Impact entities: Apprenticeship programs as private employers, State Apprenticeship Councils.

Agency roles:

19. Wagner-Peyser Act of 1933, as amended

<u>Citation</u>: 48 Stat. 113, June 6, 1933, as amended by P.L. 93-198, Dec. 24, 1973; P.L. 94-566, Oct. 20, 1976; 29 U.S.C. 49.

Description: Established U.S. policy to promote and develop a national system of employment offices. Employment opportunities based on job qualifications and nondiscriminatory employment practices are to be fostered. Regulations promulgated under the act

20. Federal Coal Mine Health and Safety Act of 1969, as amended

<u>Citation</u>: P.L. 91-173, Dec. 30, 1969, as amended by P.L. 92-303, May 19, 1972, 30 U.S.C. 938 (Supp. II, 1972).

Description: Prohibits coal mine operators from discharging or in any other way discriminating against any miner employed by them because such miner is suffering from pneumoconiosis (Black Lung disease).

Bases: Pneumoconiosis affliction (handicap).

Impact entities: Coal mine operators.

Agency roles:

Independent: Department of Health, Education, and Welfare.

Regulations: None.

21. Peace Corps Act of 1961

<u>Citation</u>: P.L. 87-293, Sept. 22, 1961, 22 U.S.C. 2504(a) (1970).

Description: Prohibits discrimination in the assessment and selection of individuals who apply for service in the Peace Corps on the bases identified below. Bases: Race, color, creed, political affiliation.

Impact entities: ACTION.

Agency roles:

Regulations: 22 C.F.R. 305.1.

22. Health Programs Extension Act of 1973

<u>Citation</u>: P.L. 93-45, June 18, 1973, 42 U.S.C. 300a-7 (Supp. III, 1973).

Description: A. Prohibits any entity which receives a grant, contract, loan or loan guarantee under the Public Health Service Act (42 U.S.C. 295, et seq.), the Community Mental Health Centers Act (42 U.S.C. 2681, et seq.) and the Developmental Disabilities Services and Facilities Construction Act (42 U.S.C. 6001, et seq.) from discriminating in the employment, promotion, or termination of employment or the extension of staff or other privileges against any physician or other health care personnel who performed, assisted, or refused to perform or assist in performing a sterilization procedure or abortion.

> B. Prohibits any entity which receives a grant or contract for biomedical or behavioral research under any program administered by the Secretary of Health, Education, and Welfare from discriminating in the employment, promotion, or termination of employment or the extension of staff or other privileges against any physician or other health care personnel because such individual performed, assisted, or refused to perform or assist in the performance of any health service or research activity.

Bases: Religious belief, moral conviction.

Impact entities: Federal financial assistance recipients under the programs specified in the act.

Agency roles:

<u>Independent:</u> Department of Health, Education, and Welfare.

Regulations: None.

23. Executive Order 11348, Training of Government Employees

<u>Citation:</u> 33 F.R. 6335, Apr. 20, 1967, 5 U.S.C. 4103 note (1976).

Description: Provides that Federal departments and agencies shall provide training for employees without regard to the bases identified below.

7. Criminal Exclusion of Jurors on Account of Race or Color Act of 1875, as amended

11. Title III, Voting Rights Act of 1965, as amended

Description: Enforces the twenty-sixth amendment to the Constitution by prohibiting discrimination by State and local governments against persons 18 to 21 years of age in the exercise of their right to vote in Federal elections, and authorizes the Department of Justice to institute civil and criminal proceedings against offending jurisdictions.

Section 817 of the act makes it unlawful for any person to coerce, intimidate, threaten, or interfere with another person's enjoyment of the rights granted by the act.
