Dear Mr. Chairman:

This letter presents information about assistance provided through federal programs related to economic development. As agreed with your office, we have listed federal programs from the December 1994 Catalog of Federal Domestic Assistance (CFDA) that the catalog describes by terms that might be characterized as economic development. We also provide levels of assistance for each program as stated in the CFDA and the associated broad budget accounts as reported by the Office of Management and Budget (OMB).

Because there is no commonly accepted definition for economic development, we selected economic development-related terms from the CFDA field that identifies common programmatic themes. However, these terms may not identify all programs in the CFDA that could be considered economic development-related because the program information in the catalog is submitted by each agency and terms may not be used consistently. In addition, the CFDA does not include all direct federal services associated with economic development. The CFDA includes nonloan (such as grant), loan, and loan guarantee programs for which state and local governments, nonprofit groups, and individuals may apply.

The CFDA lists a total of 342 economic development-related programs. The majority of these programs are administered by the Departments of Agriculture, Commerce, Health and Human Services and Housing and Urban Development and by the Small Business Administration. In addition, 13 of the 14 executive departments and many agencies and administrations have economic development programs. About three-fourths of the programs provide grants or other forms of nonloan assistance while the remainder provide loans or loan guarantees. Some programs have both a nonloan and a loan component. The purposes of the programs vary widely, from

their submittals for the CFDA. Appendix I shows funding information for each of the economic development-related programs, as reported in the CFDA. Appendixes II and III report funding information for the overall budget account that is associated with each program, by nonloan and loan programs, respectively.

To identify federal domestic economic development-related programs, we used the December 1994 edition of the CFDA. This catalog is a "government-wide compendium of federal programs, projects, services and activities which provide assistance and benefits." Coordinated by OMB and compiled by the General Service Administration, it contains information, both financial and nonfinancial, about programs administered by federal departments and agencies. The 1994 catalog lists 1,370 domestic assistance programs.


As noted above, because there is no commonly accepted definition for economic development, to determine which of the programs in the catalog were related to economic development, we selected 36 search terms that we believed could reasonably identify such programs from the field in the CFDA that identifies common programmatic themes (see app. IV). We then searched the catalog's electronic database for those 36 terms and compiled the list of economic development-related programs.

To develop information on the level of assistance provided by each program and its associated broad budget account, we extracted financial assistance data and budget account numbers from the CFDA. The CFDA assistance data were compiled in late 1994, reflecting the agencies' estimates at that time for 1994 and 1995, and may not reflect the actual assistance levels. In addition, for loan programs, amounts reported in the CFDA reflect the value of the loans rather than the effect of the loans on federal outlays. We matched the budget account numbers from the CFDA to OMB's fiscal year 1996 budget database to provide obligation data by budget account. While the budget database is the most accurate source for budget information, it does not always provide detail to the program level because an individual program, as defined by an agency, may not have its own budget account. Because of this, we provided the assistance data as reported by the federal agencies from the CFDA (see app. I) and the obligation data from OMB's budget database for the corresponding budget accounts for nonloan and loan programs (see apps. II and III). We did not independently verify the data.
