- (4) We have been advised these are the only supplementals received by AID.
- (5) These funds are for both reserves (\$81.2 million) and capital stock (\$20.0 million).
- (6) These are not appropriated funds but are available for AID use.
- (7) Includes \$30.0 million for Investment Guarantees.
- (8) \$205.9 million callable.
- (9) \$100.0 million callable.
- (10) Represents contributions.
- (11) Estimated.
- (12) Prior to fiscal year 1962, \$6,350 million was appropriated for the World Bank, of which \$635 million was paid in and \$5,715 million is callable.
- (13) Represents obligation data.
- (14) Represents authorizations (Program and administrative expenses).
- (15) For all years except 1972 funding is the total of appropriations, receipt from sales of foreign currency, and payments received from foreign governments. Estimated as of May 1971.
