Dear Mr. Chairman:

Your May 27, 1976, letter requested a comparative study of the salary and longevity schedules of the United States Capitol Police Force, the District of Columbia Metropolitan Police Force, the United States Park Police Force, and the Executive Protective Service. In accordance with this request and discussions with your office, we have compared the salary cost of Capitol Police Force members' present pay scale with the salary cost of a proposal to pay them according to the metropolitan pay scale applicable to members of the three other police organizations.

The metropolitan pay scale used in our comparison included the 6-percent increase provided for in the fiscal year 1976 District of Columbia appropriation bill. Our comparison was based on converting the 1,140 Capitol Police Force members to the grades and steps they would attain under the metropolitan pay scale. Information on rank and length of service was provided to us by the Capitol Police; we did not verify this data by reviewing the personnel files of each member of the force. The results of our study are shown in the following comparison of salaries.

The comparison shows that placing the 1,140 members of the Capitol Police Force under the metropolitan pay scale would result in an estimated annual cost increase of \$1,753,044. It also shows that of this additional cost, 93.2 percent would be applicable to the three lowest ranks, which comprise 86.6 percent of the Force. Similarly, the members in these ranks would receive the largest average individual salary increases.

As a result of the conversion, the salaries of two members of the Capitol Police Force would be reduced. We understand that the plans for placing the Capitol Police Force under the metropolitan pay scale would include a "saved pay" provision. Therefore, \$810 for "saved pay" would be additional to the cost increase previously discussed.
