This letter responds to your request for information on the funding levels for manufacturing extension centers that receive federal funds and the dates they began receiving such funding. These centers offer various services to businesses, such as helping them improve plant layout, product design and development, energy efficiency, and address environmental issues. As agreed with you, we obtained this information from the National Institute of Standards and Technology (NIST). The information was sent to us from the NIST Budget Office, and we have not independently verified it.



Enclosures 2 and 3 show those funded through the Technology Reinvestment Project (TRP) under the Advanced Research Projects Agency (ARPA). These projects are being funded in two rounds. The first round consists of projects funded in fiscal years 1994 and 1995 with funding planned for 1996; the second round consists of projects funded for fiscal year 1995 and planned funding for fiscal year 1996.
