To the President of the Senate and the Speaker of the House of Representatives

On December 7, 1982, the President's second special message for fiscal year 1983 was transmitted to the Congress pursuant to the Impoundment Control Act of 1974. The special message proposes thirteen deferrals totalling \$1,569,870,000 and revisions to three previously reported deferrals which increase the amounts deferred by \$1,173,257,000. Our report follows.

On January 5, 1983, the President submitted a revision to this report reflecting an increase in total budgetary resources from \$800 million to \$810 million, and a corresponding increase in the amount deferred from \$234 million to \$244 million. The \$10 million increase is attributable to a recent revised estimate of the amount of unreserved and unobligated funds carried forward into fiscal year 1983.

According to agency officials, \$17 million was deferred in anticipation of reimbursements from sale to a commercial user of part of a 1984 Space Shuttle flight no longer needed for launch of the fourth Tracking and Data Relay Satellite. The remaining \$17.5 million deferred is due to delayed procurement of two Interim Upper Stage vehicles previously planned for launch with the fifth and sixth Tracking and Data Relay Satellites.

The deferral message indicates that the project will be delayed for at least a year. An agency official told us that the project probably will not be included in the agency's budget for fiscal year 1984. According to the official, the increased capacity of the cemetery due to a decrease in gravesite size has delayed the need for further gravesite development at Indiantown Gap National Cemetery for at least 5 years. If the project is delayed, the deferred funds can be used to cover contingencies in other projects and to offset the agency's new budget request.

The amount listed as unobligated balances in this account in the deferral message (\$833,739,101) was an estimate. As shown on the current apportionment form, the actual amount of unobligated balances is \$833,299,101, a decrease of \$440,000.

We have reviewed the second special message. Except as noted above, we have identified no additional information that would be useful to the Congress in its consideration of the President's proposals and we believe that the proposed deferrals are in accordance with existing authority.
