To the President of the Senate and the Speaker of the House of Representatives

On December 14, 1983, the President's third special message for fiscal year 1984 was submitted to the Congress pursuant to the Impoundment Control Act of 1974. The special message proposes six new deferrals totalling \$368,428,000 and revisions to four previously reported deferrals totalling \$997,126,000. Our report follows.

FUNDS APPROPRIATED TO THE PRESIDENT

D84-24 International Security Assistance Economic Support Fund Amount deferred: \$303,880,000 1141037

The figures shown on the deferral message represented the status of the account through November 14, 1983, under Public Law 98-107, the first continuing resolution for fiscal year 1984. These figures now have been superseded. The most recent apportionment form for the account shows total budgetary resources of \$2,930,250,000, the amount available for all of fiscal year 1984 under Public Law 98-151, the second continuing resolution for fiscal year 1984. Of that amount, a total of \$1,472,471,000 is deferred as of December 28, 1983.
