Dear Senator Simon:

Your March 12, 1986, letter requested that we provide you with information on social and economic problems affecting the city of East St. Louis, Illinois. Specifically, you asked us to provide you with information on Department of Housing and Urban Development (HUD) and other federal, state, and local funding for East St. Louis by program for fiscal years 1974 through 1985. In addition, you requested that we provide historical demographic data on social and economic conditions in the city. On April 15, 1986, we briefed your office on the results of our work. This fact sheet summarizes the information that we provided during our briefing.

To analyze HUD activities and funding in East St. Louis, we interviewed HUD officials and reviewed various funding records in the Department's headquarters in Washington, D.C. and its regional office in Chicago, Illinois. Information on other federal, state, and local funding was developed primarily from Bureau of the Census reports. We also analyzed reports on East St. Louis prepared by Illinois community service agencies, state offices, and independent accounting firms. To provide information on the historical demographics of social and economic conditions in the city, we reviewed materials available from the Bureau of the Census and an in-depth series of newspaper articles published in 1983 describing developments in East St. Louis since the turn of the century.

We did not independently verify any of the funding or demographic data or other information. Also, information in this fact sheet often covers different periods of time because of the varying ways that data were collected in the reports.

In summary, we found that, during fiscal years 1977 through 1979, the only years for which we could obtain estimates, total federal funding was about \$100 million annually. HUD provided over \$131 million to aid the people and the city of East St. Louis from fiscal year 1974 through 1985. Demographic data on East St. Louis show that social and economic conditions in the city have been declining steadily. B-223427

Part I of this fact sheet illustrates federal, state, and local funding statistics relating to East St. Louis. When possible, we compared these statistics with national data. Part II outlines social and economic demographic data pertaining to the city and compares the data with relevant national data. Part III summarizes a series of newspaper articles which describe the events in East St. Louis which have contributed to its current social and economic condition. These articles were previously provided to your office.

We obtained the views of HUD officials on the information discussed in this fact sheet and included these views as appropriate. As arranged with your office, unless you publicly announce its contents earlier, we plan no further distribution of this fact sheet until 30 days from the date of this letter. At that time we will send copies to interested parties and make copies available upon request.


HUD AND OTHER FUNDING FOR EAST ST. LOUIS, 1974-85

- HUD PROVIDED ABOUT \$131 MILLION IN AID TO THE PEOPLE AND CITY OF EAST ST. LOUIS DURING FISCAL YEARS 1974 THROUGH 1985. FROM THE VARIOUS HUD ASSISTANCE PROGRAMS, EAST ST. LOUIS RECEIVED OVER \$30 MILLION IN COMMUNITY DEVELOPMENT BLOCK GRANTS, OVER \$67 MILLION FOR PUBLIC HOUSING, AND OVER \$12 MILLION FOR URBAN RENEWAL PROJECTS.
- BETWEEN FISCAL YEARS 1977-79, THE ONLY YEARS FOR WHICH WE WERE ABLE TO OBTAIN ESTIMATES, EXPENDITURES BY ALL FEDERAL AGENCIES FOR EAST ST. LOUIS WERE ABOUT \$100 MILLION ANNUALLY. THIS FIGURE INCLUDES MONEY GIVEN TO THE CITY AS WELL AS ASSISTANCE GIVEN DIRECTLY TO RESIDENTS, SUCH AS WELFARE ASSISTANCE AND FOOD STAMPS.
- THE CITY'S FEDERAL AND STATE REVENUE SOURCES FOR CALENDAR YEARS 1974-84 TOTALLED \$111,596,000 AND \$25,068,000, RESPECTIVELY. INCLUDED IN THE FIGURE FOR FEDERAL REVENUES IS OVER \$18 MILLION IN REVENUE SHARING. LOCAL REVENUE SOURCES OVER THE SAME PERIOD GENERATED \$91,955,000.
- OF THE VARIOUS TAX REVENUES OF \$67,881,000 RECEIVED BY EAST ST. LOUIS DURING FISCAL YEARS 1974-84, PROPERTY PROVIDED \$35,209,000, SALES PROVIDED \$28,104,000, AND MISCELLANEOUS SOURCES PROVIDED \$4,568,000.




Figure I.2: Amount of Revenue for East St. Louis^a (1974-84)

PART II

DEMOGRAPHIC DATA ON EAST ST. LOUIS

- POPULATION HAS DECLINED STEADILY, FROM OVER 82,000 IN 1950 TO SLIGHTLY MORE THAN 55,000 IN 1980. BETWEEN 1970-1980, THE TOTAL POPULATION OF EAST ST. LOUIS DECLINED BY 21 PERCENT. IN 1980, THE MEDIAN AGE FOR THE EAST ST. LOUIS POPULATION (22.7) DIFFERED MARKEDLY FROM THE MEDIAN AGE FOR THE UNITED STATES (30).
- THE RACIAL MAKE-UP OF THE CITY OF EAST ST. LOUIS HAS UNDERGONE A CONSIDERABLE TRANSFORMATION. IN 1960, 55 PERCENT OF THE CITY'S POPULATION WAS WHITE AND 45 PERCENT WAS "NON-WHITE". IN 1980 THE DISTRIBUTION HAD SHIFTED; THE WHITE POPULATION ACCOUNTED FOR LESS THAN 5 PERCENT OF THE POPULATION WHILE THE "NON-WHITE" POPULATION CONSTITUTED 95 PERCENT OF THE CITY'S TOTAL POPULATION.
- ANNUAL FAMILY INCOME IN CONSTANT DOLLARS FOR EAST ST. LOUIS DECLINED FROM \$15,927 IN 1959 TO \$12,117 IN 1979. CONVERSELY, FAMILY INCOME FOR THE UNITED STATES AS A WHOLE INCREASED FROM \$18,486 TO \$27,183 DURING THE SAME PERIOD.
- THE PERCENTAGE OF FAMILES IN EAST ST. LOUIS WITH INCOME BELOW THE POVERTY LEVEL IN 1979 WAS NEARLY 39.0 PERCENT, COMPARED WITH THE NATIONAL AVERAGE OF 10.3 PERCENT. THE PERCENTAGE OF FAMILIES RECEIVING PUBLIC ASSISTANCE INCOME IN THE CITY IN THAT YEAR WAS MORE THAN 37 PERCENT.
- IN EAST ST. LOUIS, THE PERCENTAGE OF INDIVIDUALS UNEMPLOYED INCREASED FROM 10.5 PERCENT IN 1960 TO 21 PERCENT IN 1980.
 FOR THE SAME PERIOD, UNEMPLOYMENT IN THE UNITED STATES INCREASED FROM 5.5 PERCENT TO 7.1 PERCENT.
- AVAILABLE HOUSING UNITS IN THE CITY DECLINED FROM ALMOST 26,000 IN 1960 TO LESS THAN 19,000 IN 1980. DURING THE SAME PERIOD, THE PERCENTAGE OF VACANT UNITS IN EAST ST. LOUIS ROSE FROM LESS THAN 4 PERCENT IN 1960 TO OVER 11 PERCENT IN 1980.
